

New ERP solutions are replacing the old solutions, which forces companies to consider how to implement the new solutions to support their future business

New ERP solutions

Several ERP vendors have replaced their old solutions with modern solutions – examples of main ERP solutions used in Denmark being:



The new solutions highly resemble the old solutions, but are new recoded solutions to embed and support new technologies, e.g.:

- Cloud offerings and services
- AI, machine learning and process automation
- Realtime analytics
- Increased usability and mobility
- New database technologies
- Increased segregation "Best-of-breed" and "Best-of-suite"

Many companies still run old ERP solutions

What we often see:

- Original implementations are 15 25 years old
- The level of process and solution standardization is low
- Different reports show different numbers for same KPI's
- Solutions contain high level of customizations
- Businesses have changed significantly since the implementations
- ERP solutions are cumbersome to adapt to new requirements

- Many lack the apatite for initiating a large ERP project due to cost, resources, focus, and risks


